## HANDLING COMPLETED PETITIONS

1. Each Petition once signed by a Registered Voter is a confidential document and must be protected. The petition contains private information of a California Voter. Misuse of the information is crime.

DO NOT leave Petitions in a car, unsecured or copy them. Treat Petitions like money, they are valuable.

- 2. Upon completion of signature gathering:
  - a. Count and record the number of Petition pages.
  - b. Count and record the number of signatures.
  - c. Count and record the names of the counties.
- 3. Fill out and Sign all Petition pages. See Below for Example
- 4. Contact your TCB County Captain or send in the data to info@takecaback.org.
- 5. Arrange for the immediate transfer of the petitions for filing.

## **EXAMPLE**

- A. Enter the County the Petition is representing.

  Example: Signers are from Yolo, the County is Yolo
- B. Complete your name address as appropriate and the month/day and year you started that Petition and the month/day and year you completed that petition.
- C. Date, enter the city or community where you are certifying or signing the Petition and then sign and date the Petition using your registered voters signature and month/day and year.
