- 4. My affidavit highlights: The software for Dominion voting machines was made in Serbia by Serbian IT engineers; In the election night the voting machines were connected to the IP address in Belgrade;
- 5. Dominion Voting Systems has two companies in Serbia:
- 1) Dominion Voting Systems Representation that's been operating since 2005.
- 2) Dominion Voting Systems Europe Branch that was established in 2011.

Both companies were located at the same address: Osman Djikic Street number 18, Belgrade. Vice president of Dominion and director of Dominion Branch in Belgrade Goran Obradovic owns a patent for voting machines. Bojan Djordjevic admitted during Twitter exchange on my account that the software for voting machines was written in Belgrade, he was the first to mention the Venezuelan company ES&S and he admitted the fact that he is familiar with the US election system. He also admitted that the software wasn't sold by Dominion Representation, but by some other company. Shortly after this he deleted all of his tweets and locked his account. Bojan Djordjevic is a director of Dominion Representation in Belgrade, and in the middle November 2016. he resigned from his position as director of Dominion Branch. This is very odd and also a legal nonsense, because the decision that establishes Bojan Djodjevic as the director of Dominion Branch does not exist.

I suppose that software was sold through Dominion Branch because it couldn't have been legally sold through Dominion Representation, or it was sold through some other company that is being used for the extraction of money.

In 2019 Dominion Branch reported negative balance in the amount of 350.000 dollars. A company that practically elects the President of the US and members of the European Parliament has a negative balance. Also, it was stated that Dominion Europe Branch is located in Belgrade and that the registered owner is Dominion Canada.

In August, 2016, Hunter Biden was in Belgrade incognito, during his father's official visit to Serbia. This is when he visited Dominion headquarters at the address Osman Djikic Street number 18 where both the headquarters of the Branch and the Representation were located. The proof of this claim is located in his laptop which is

currently in the possession of the FBI. Key persons for resolving the issue of election fraud in the US are Goran Obradovic, Bojan Djordjevic and Ranko Stamatovic because they are directors of Dominion companies in Serbia and they definitely met Hunter Biden during his visit to Dominion in Belgrade. These persons also met Hunter Biden at the aforementioned time.

Every software must be upload in every machine. You have changes in every election because you have new candidates, different serial numbers, dates etc. These changes must be uploaded in every machine. It is impossible to do this physically. This is why all the machines are being connected to the internet and the changes are being uploaded all at once, simultaneously. The person who has the access codes can gain access and do anything he wants. Serbian software engineers who made the software know everything. They did this for money or following someone's orders. In lawsuits, there are expertise that prove that the software was programmed at the beginning to add votes to Biden. The first person in the whole world who published this fact is a friend of mine. Furthermore, it is indisputable that the counting of votes was stopped in the election night. It is also indisputable that the voting machines were connected to the internet.

According to the information, there was a report prior to November 3, 2020, which was filed from Serbia to the public ad @RFJ_USA REWARD FOR JUSTICE. However, competent authorities didn't react to this report and they didn't contact the person who responded to the ad. If they did their job that was described in the ad, everything could have been prevented.

6. According to the information that were published, one of the IP addresses to which they were connected is located at the address Zoran Djindjic Boulevard number 8a, where corporative offices of TV channel Nova S. The internet network which provided support is SBB networks. Both Nova S and SBB are a part of United Group. Head office of United Group is in Amsterdam, and the key man is Dragan Solak. United Group was owned by the investment fund KKR and its chairman is former head of CIA General David Petraeus. In 2018 it sold the majority package of United Group to the investment fund BC Partners. However, KKR retained the control package and managing rights until 2021. Based on these information it is clear that the whole election fraud operation in Serbia was managed by General Petraeus, which is logical considering the fact that 20 years ago CIA took full control of Serbia.

Soros is the boss of Balkans and Serbia, and another pillar is the CIA, which conducts, directs and controls. The system was built in the second half of the nineties, and was fully completed after the colored revolution in 2000. The main people who installed this system in Serbia were David Roseman, Bill Jameson and Sean Fitzpatrick.

Sean Fitzpatrick was the representative of CIA in Belgrade at the end of nineties. He made his career in marketing, in McCann-Erickson, where he was a longtime vice president. Under that cover, he cooperated with intelligence services in different states.

David Roseman was a CIA servant for some 30 years. During his service, he worked in 150 states. He was in charge of the legality of CIA

operations worldwide, and represented CIA in negotiations of mixed jurisdiction with FBI and the Department of Defense after 9/11 attack in 2001.

He was also the main mediator who conducted the negotiations in Bosnia and Herzegovina about forming of common intelligence service after the war. The CIA leader in Balkans for 20 years was the "late" John David Neighbor, who was arrested in 2002 as CIA chief in Belgrade, together with General Momcilo Perisic, in that time Vice President of the Government of Serbia and former Chief of the General Staff of the Army of Yugoslavia and charged with espionage. After being released he was "killed" in Hungary, and CIA "resurrected" him under new name and sent him to Sofia, from where he conducts the works of CIA and British MI6 in Balkans. The mentioned people established CIA control in Serbian judicature, security services and politicians, so therefore Belgrade was the safe house to conduct the election fraud in America.

During the investigation of the election fraud, the existence of so-called "backdoors" to the system was discovered along with persons that accessed the system from China, Iran, Serbia and interfered in US election system. But how did the "hackers" from Iran infiltrate into the US election system? Something like that could have been done only by Iranian intelligence MOIS. Considering the fact that CIA is behind the election fraud in the US, this would mean there is a certain kind of cooperation between CIA and MOIS! The contact was probably made right here in Serbia. Serbia is under CIA control and in the last few years Serbia started an intensive cooperation with Iran. That would not be

possible without the CIA approval. A visa-free regime and direct airline were introduced, opening of Iran's regional economic center was announced, frequent diplomatic visits of senior government officials were made, but in October, 2018, all of this came to an abrupt end. At the session of Serbian government, which lasted merely 10 minutes without any discussion whatsoever, ministers decided to abolish the visa-free regime. This was also a chance for MOIS agents to infiltrate into Europe posing as migrants. Some of them entered the EU, using Serbian passports which were given to them in Belgrade.

This cooperation was terminated after the visit of NATO Secretary

General Stoltenberg to Belgrade and his meeting with Serbian President

Vucic. During this meeting Stoltenberg presented to Vucic the

information concerning the entry of MOIS agents through Serbia into

Europe.

This cooperation between Serbia and the Iranian intelligence agency wasn't limited exclusively to the infiltration of new agents into Europe and to providing them with Serbian passports. Serbian media published the news concerning Iranian service agents that were arrested in South America and who had in their possession original Israel passports. These passports were from the series that was printed in Serbia.

Good cooperation between Serbia and MOIS, with CIA approval, is

further confirmed by the meeting that Serbian President had in Sofia with General Qasem Soleimani. Journalist Predrag Popovic wrote on this topic and published the picture taken at that meeting. HQ of the CIA for this

part of Europe is located in Sofia and is run by the "late" John David Neighbor. Sofia was selected to be a safe place for this meeting because they hoped this would give them a necessary protection. On March 8, 2018, during the National Assembly session, member of parliament Zoran Radojicic spoke about Vucic's visit to Sofia.

7. It is through Serbia that telecommunication and IT equipment is being delivered to Iran, through the use of the company belonging to Nenad Kovac AKA Nesa Roaming who is the representative of both Huawei and ZTE. That is how Serbia and Nesa Roaming are in direct violation with American sanctions imposed against Iran. Nesa Roaming came a long way from a small-time mobile phone smuggler to the biggest and most powerful monopolist. It took him only a few years. He was created by CIA agent Miki Rakic who was the Head of Serbian Security Services during the Presidency of Boris Tadic.

Nenad Kovac aka Nesa Roaming is a link that connects former and current government.

Nenad Kovac was involved in laundering of money gained by drug trade that was conducted by Darko Saric drug cartel. However, his wiretapped conversations were removed from court files and declared a state secret.

Nenad Kovac

became the object of interest to the American congressmen, who mentioned him in a letter written to the Vice President of the United States Mike Pence. The aforementioned congressmen wrote that Kovac is one of the 5 most powerful persons in Serbia, 5 people who formed a small group which controls all the businesses that are financed from the budget.

There is a reasonable suspicion that companies owned by Nenad Kovac are involved in the laundering of money belonging to the American taxpayers through USAID projects and that these money was used for the financing of terrorism in the US.
