

PETITION FOR RECALL

TO THE HONORABLE SECRETARY OF STATE OF CALIFORNIA,

Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the State of California, respectfully state that we seek the recall and removal of Gavin Newsom holding the office of Governor of California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on August 23, 2019 to Governor Gavin Newsom:

TO THE HONORABLE GAVIN NEWSOM: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of GOVERNOR in the State of California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

Governor Gavin Newsom has violated the trust of California residents in four major areas:

Health care for illegal aliens. He seeks to make California taxpayers pay for the health care of criminal lawbreakers who entered our nation illegally at a starting cost of over \$100 million. This policy will serve as a magnet to attract thousands more illegal immigrants to California which will lead to skyrocketing costs and additional burdens on physicians and hospitals.

Tax increases. Despite a massive budget surplus of \$21 billion, he proposes more than \$2 billion in additional taxes on the people of California, including a water tax. California already has the highest taxes in the nation which are driving away our best residents and businesses.

Homelessness. He has allowed our major cities to be overrun by homelessness, creating a threat to public health and hygiene and leading to Third World-like conditions and diseases in places like Los Angeles and San Francisco

Sanctuary State & Cities. He has violated and subverted federal immigration law by encouraging "Sanctuary State" and city policies that shield criminal illegal aliens from law enforcement and immigration authorities, including vicious and brutal MS-13 gang members.

Less than one year ago, by historic margins, California voters elected Gavin Newsom Governor.

Since then, Governor Newsom has already made good on his promises to 1) increase funding for public education, 2) protect and secure your health care, 3) improve water, roads and bridges and 4) prepare California for wildfire threats.

Our budget is balanced. Our reserves are unprecedented. Our state economy and employment have hit historic highs.

Yet a handful of partisan activists supporting President Trump and his dangerous agenda to divide America are trying to overturn the definitive will of California voters and bring Washington's broken government to California with this recall effort.

The last thing California needs is another wasteful special election, supported by those who demonize California's people and attack California's values.

Do not be fooled - California's police officers, firefighters, first responders, public school teachers, health providers, and business leaders all STRONGLY OPPOSE this costly recall.
