RECALL PETITION

TO THE HONORABLE Secretary of State of California: Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of Senate District 6, in the State of California, respectfully state we seek the recall and removal of Dr. Richard Pan, holding the office of State Senator in District 6, California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on May 28th to Richard Pan. TO THE HONORABLE Richard Pan: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of District 6, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of State Senate, in District 6, California, and to demand election of a successor in that office. The grounds for the recall are as follows: You are hereby charged with high treason for betraying your oath to defend and protect the U.S. and state Constitution. You sought to censor free-speech by forcing social-media to filter communications through government sponsored "fact-checkers," despite California law also forbidding the abridgment of free-speech "Every person may freely speak, write and publish... on all subjects."
