

Recall Petition Instructions

One or two registered voters may sign the petition by completing a box:

PART 1: Each person must <u>in their own handwriting</u> print their name and residence address, then sign on the line provided.

All signers on a petition must be a registered voter in the county designated on the petition.

PART 2: In the box "DECLARATION OF CIRCULATOR" you must fill in all shaded areas in your own handwriting. Follow the instructions carefully and make sure to <u>fill in all the blanks</u> to avoid rejection of the petition.

- Only registered voters of California may sign petitions.
- You may circulate as many petitions as you wish, however, you can only sign the recall petition once. You must sign as a circulator on every petition you circulate.
- You can circulate petitions in more than one County, but all signers of each petition must be from the same county. <u>Start a new petition for each County.</u>
- A petition is valid even with only one signature. <u>Be sure if you are the single signer on the petition that you also sign as circulator.</u> A one signature petitition <u>must</u> have the signature in both places.
